The above eligible candidates are also advised to bring all original certificates etc. along with one set of attested copies in support of age (date of birth), educational / professional qualifications, experience, caste (i.e. SC/ST/OBC) as mentioned in the Advertisement / Application which are to be produced on the date of Interview, failing which the candidates will not be allowed to appear in the interview. Please also bring **4 (four) recent passport size photographs (front pose) duly attested by a Gazetted Officer at the time of Interview positively.**

Candidates belonging to SC/ST/OBC(**NON-CREAMY LAYER**) category MUST produce the attested copy of their latest valid caste certificate issued by the competent authority in the prescribed form in line with GOI Rules / Orders at the time of Interview positively for ascertaining their candidature, failing which they will not be allowed to appear in the interview.

Candidates are entitled to single to and from 2ND Class Railway Fare by shortest route for the journey performed to attend the interview from their nearest railway station to Howrah / Sealdah / Bidhannagar Railway Station on production of Railway Ticket / Ticket No. for onward journey as per the rules of the Corporation. Please note that the railway fare will be reimbursed only for the journeys made from the station as mentioned above and not from any other station.

If they fail to bring all the required certificates in original, No Objection Certificate from present employer, 4 (four) passport size photographs, caste certificate (i.e. SC/ST/OBC) from competent authority, they will neither be interviewed nor their railway fare will be reimbursed.

Interview Letters are under issuance. In case of non-receipt of interview letter, eligible candidate as per the list mentioned above, is hereby advised to appear in the interview as per the schedule along with a copy of this notification (to be downloaded from DVC website) and a copy of the ADMIT CARD(duly filled in), the format of which is given in the next page.
